## 4 STEAMING SERVICES

Port of HaminaKotka Ltd provides steaming service for example for the removal of ice from ship structures and for the thawing of deck cargo and containers. The steaming service includes the operating personnel of the equipment and any necessary transport on wheels.

The steam generator can also be lifted to a vessel in a work container. Steaming services are provided primarily for purposes related to maritime transport, but they are also very convenient in other thawing and heating work in the Port area. Any lifting equipment costs are not included in the price of the steaming service.

The steam generating equipment is offered at the hourly rate stated below within the normal working hours of the Port, in two shifts. Steaming service taking place at other times shall be agreed upon separately. Any additional personnel and work outside the normal working hours is charged in accordance with the price list for hourly work.

## 5.2 GENERAL CONDITIONS
